The Lazydays Employee Foundation's 3rd Annual Golf Tournament Raises More Than \$101K for At-Risk Youth

All proceeds from this golf tournament will go toward making a difference in the lives of at-risk children in the Tampa Bay area.

Chiodi noted, "We had a small, but dedicated group of volunteers who worked tirelessly on this tournament, in addition to having a full-time job. The tournament was a lot of work, but well worth the effort."
